I, **Deepak Gupta**, partner of DR Associates, Company Secretaries, was appointed as the scrutinizer for the purpose of scrutinizing the postal ballot through remote e-voting through the platform provided by Central Depository Services (India) Limited (CDSL) -[www.evotingindia.com](http://www.evotingindia.com) in a fair and transparent manner and to ascertain the requisite majority as per provisions of Sections 108, 110 and other applicable provisions, if any, of the Companies Act, 2013, ("the Act"), read together with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, including any statutory modification or re-enactment thereof for the time being in force, by the Board of Directors of the company at their meeting held on 15<sup>th</sup> April, 2022 in respect of the resolution contained in the Postal Ballot Notice dated 15<sup>th</sup> April, 2022.

I submit my report as under:

1. The company has in pursuance of MCA circulars not sent the hard copy of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope to the shareholders for this Postal Ballot and only assent/dissent were required to be communicated through the remote e-voting system only by the shareholders, whose names appeared on the register of shareholders/list of beneficiaries by e-mails whose email ID were registered either with the depositories or with the Company, as on 18<sup>th</sup> April, 2022
2. As prescribed in the said Rules, the Company has also published an advertisement in Newspapers i.e. Financial Express (English) and Nawan Zamana (Punjabi) on 25<sup>th</sup> April, 2022 and it carried the required information as specified in the said Rules.
3. There was no instance of any Postal Ballot forms being received by the Company.
